2. The vehicle will be disposed of on "As is where is basis".
3. The bidders have to attach an self attested copies of Ration Card/ Aadhar Card, Voter I.D. Card, PAN Card, GST registration certificate and two recent passport size photographs duly attested along with the bid documents.
4. The successful tenderer/bidder will be responsible for getting the registration certificate of the vehicle in his name expeditiously. The CAA will not be responsible for any lapse on the successful tenderer part in this regard.
5. The bidders will not be allowed to withdraw their bids failing which their earnest money will be forfeited.
