- (ii) Age: Should NOT have completed 56 years of age as on the clothing date of receipt of applications.

- **Eligibility**: Officers under the Central Government or State Government or Union Territories or Agriculture Universities or Recognized Research Institutions or Councils or Semi Government or Statutory or Autonomous Organizations:-
 - (i) Holding analogous post on regular basis in the Parent cadre/Department or
 - (ii) Having eight years regular service in 7th CPC in Level -2 (pre-revised pay scale of Rs.5200-20200 + Grade Pay Rs.1900 in PB-1) or equivalent in the parent cadre of Department.
- (i) Having five years experience in establishment and administrative matters in the Government Department.
- (ii) Age:- Should **NOT** have completed **56 years of age** on the closing date for receipt of applications.

General Information:

- 1) Experience specified for the above posts shall be the experience acquired after obtaining the prescribed educational qualifications.
- 2) The terms and conditions of deputation are governed by the GOI, Dopt.No.6/8/2009-Estt.(Pay II), dated:17/06/2010 and as amended from time to time
- 3) Candidates will have to produce proof of details furnished in their application as and when required.
