## Requirement for Quarantine Clearance for SPF L.Vannamei

- An application has to be made to the Animal Quarantine & Certification Service minimum three days and maximum seven days in advance,
- The proforma of the application can be procured from the AQCS office well in advance before the import, a copy of the same is annexed.
- The application should state about the consignment to be imported, date of import, carrier, country of import, Xerox copy of the health certificate as per the conditions laid down in the Sanitary Import Permit.
- A copy of the Sanitary Import Permit, Invoice, Packing List, Airway Bill, Country of Origin has to be submitted along with the application.
- All the papers will be subjected to pre import vetting by AQCS and if found in order a letter of No Objection is issued to the concerned Airlines for accepting the said consignment.
- The shipment will be checked in person by the Officer In charge at the port of entry and all original documents accompanying the shipment will be checked once again.
- A provisional Quarantine clearance will be issued at the port of entry and if found satisfactory after inspection of consignment and papers.
- The consignment will be taken in government approved Aquatic Quarantine station for necessary observation and testing.
- Animal Quarantine clearance Certificate will be issued for the said consignment in case the samples tested are found to be negative to OIE listed diseases during Quarantine period.
