**Advisory to the Hatcheries/ Nauplii Rearing Hatcheries to furnish the Quarterly Compliance Reports to the CAA**

Para 9(2) of part I of Guidelines for regulating hatcheries and farms for seed production and culture of Specific Pathogen Free (SPF) *L. vannamei* prescribed that

"(2) The hatcheries shall maintain a record of the imported broodstock with details of source, quantity imported, the number of mortality, eggs produced, nauplii produced, post-larvae produced, post-larvae sold, name and address of the farmer to whom sold, date and number of the registration and permission certificate issued by the Authority and report these in their quarterly compliance report to be submitted to the Authority in Form-B-I of these Guidelines."

Para 8 (2) of of Guidelines for seed production and culture of Specific Pathogen Free (SPF) *P. monodon* prescribed that

"(2) The hatcheries shall maintain a record of the imported broodstock or indigenously certified broodstock of specific pathogen free status with details of source, quantity imported, or procured from indigenous sources, the number of mortality, eggs produced, nauplii produced, post-larvae produced, post-larvae sold, name and address of the farmer to whom sold, date and number of the registration and permission certificate issued by the Authority and report these in their quarterly compliance reports to be submitted to the Authority in Form-C-I annexed to these guidelines."

Hence, all the hatchery/NRH operators are requested to furnish their Quarterly Compliance Reports to CAA regularly as per the following schedule without fail.

Sl. No.	Quarters	Months	Last date of submission
1.	First	April to June of every year	On or before 15 <sup>th</sup> of July
2.	Second	July to September of every year	On or before 15 <sup>th</sup> of October
3.	Third	October to December of every year	On or before 15 <sup>th</sup> of January
4.	Fourth	January to March of every year	On or before 15 <sup>th</sup> of April

Format prescribed for submission of Quarterly Compliance Reports to the CAA are attached herewith. The hatcheries permitted for the seed production of *L. vannamei* shall submit in Form-B-I and the hatcheries permitted for seed production of *P. monodon* shall submit in Form-C-I.

It is also informed that non-submission of the Quarterly Compliance Reports in time will be treated as the violation of CAA Act, Rules and Guidelines and penal action will be initiated against those hatcheries and NRHs in accordance with the provisions contained under Section 14 of CAA Act, 2005.
