Expression of Interest (EoI) called for from the existing shrimp hatcheries for purchase of SPF brood stock of *P. monodon* from DTSP Project of MPEDA-RGCA for production of SPF *P. monodon* seed and supply to registered shrimp farmers

It is to inform that, MPEDA under "Domestication of Tiger Shrimp Project (DTSP)" produced the SPF brood stock of *P. monodon* to promote the revival of the disease free culture of indigenous *P. monodon* in the country. The first batch of SPF brood stock of *P. monodon* reared at BMC, Vizag is ready for supply from the month of November, 2023 onwards to the CAA approved hatcheries which have required facilities. The Committee constituted by MPEDA during the meeting held on 06-10-2023 has discussed modalities for supply of SPF brood stock of *P. monodon* through MPEDA-RGCA and recommended to the CAA to call for EoI from the existing registered hatcheries, which are willing to purchase SPF brood stock from DTSP, A&N Islands and BMC, Visakhapatnam for production of SPF *P. monodon* seed and supply to the registered farms.

In this context, an Expression of Interest is called for from the existing registered shrimp hatchery operators, who are willing to purchase SPF brood stock from DTSP, A&N Islands and BMC, Visakhapatnam and have required facilities for the production of SPF *P.monodon* seed and supply to the registered farms.

The interested hatchery operators shall submit a fresh application in the prescribed form, which can be downloaded from the CAA website (www.caa.gov.in), within 15 days *i.e.* by 25<sup>th</sup> October, 2023 duly enclosing the processing fee of Rs. 10,000/- in favour of CAA, payable at Chennai in the form of DD and a copy of the certificate of Registration. A copy of the Guidelines for maturation and seed production of SPF *P. monodon* is attached along with EOI.

On receipt of the application in full shape, the designated Inspection Committee will inspect facilities at hatcheries to ensure the suitability of the hatchery for maturation and seed production of SPF *P. monodon*. The CAA will grant the certification of registration to hatcheries that comply with CAA Guidelines and are recommended by the committee for the remaining valid period of registration. The annual allocation of broodstock to purchase from MPEDA-RGCA will be made based on the facilities available at the maturation section. However, the MPEDA, based on the availability, will supply the brood stock of SPF *P. monodon* on a first come, first serve basis.
